UPDATE ON ABLE ACCOUNTS

Since the implementation of the Oregon ABLE Savings Plan in December 2016, we at the OSNT have been receiving inquiries into the process of transferring funds from an individual's subaccount into an ABLE account.

Even though the Center for Medicare and Medicaid Services (CMS) has issued a general guideline indicating such transfers would not be considered income for purposes of Medicaid eligibility, that does not apply to Social Security benefits, or to the rules surrounding administration of a special needs trust.

The OSNT is a pooled trust and there are specific guidelines we must follow when administering the trust and authorizing activity within each beneficiary subaccount. Specifically, the Program Operations Manual System (POMS), published by the Social Security Administration dictates very specific rules around the administration of pooled special needs trusts. As of this date, the POMS have not been updated to offer any insight or guidance as to how a transfer of pooled trust funds to an ABLE account will be viewed by the Social Security Administration, or how the transfer would affect a person's benefits or eligibility for benefits.

To gather more information on this issue we spoke with Stephen Dale, at The Dale Law Firm, who specializes in special needs trusts and is one of the country's leading experts in the field. Mr. Dale has confirmed he is not aware of any pooled trusts that are currently authorizing transfers of pooled trust funds into ABLE accounts. The main reason for this is the lack of guidance from the Social Security Administration as noted above. Mr. Dale believes the most prudent course of action is to wait for the updated POMS guidelines before establishing any policy or practice around transfers into ABLE accounts.

The Arc Oregon Board of Directors was provided with the information as outlined above and agreed to hold off on implementing any policy or authorizing any transfers until the POMS guidelines are published. Once the POMS updates are available, we will revisit this issue to review the guidelines and determine when transfers may be allowable and appropriate, and will develop specific policies about when transfers would be allowed based on what is in the best interest of each individual account holder.

BENEFIT VERIFICATION

By now you should have received the annual letter from Social Security that confirms what your new monthly benefit payment will be in 2018.




ONLINE ACCOUNT ACCESS

We are aware that many of you have tried to access the account login from our website to check your account balance, and have continued to receive an error. We sincerely apologize for any inconvenience that has caused. We have been working with our IT staff and have discovered the problem with the online portal is that we do not currently have a proper firewall securing the network and therefore your information would not be guaranteed to be secure. Your financial safety and privacy is of utmost importance to us! We anticipate having a firewall in place by the end of April, if not sooner. In the meantime, should you need an account statement, please do not hesitate to contact our office and we would be happy to provide you with one.

TAX STATEMENTS

Every year our beneficiaries and donors receive a tax statement from us pertaining to their OSNT sub-account. This year you should look for your tax documents to arrive from Key Private Bank by Mid-March.









MONTHLY STATEMENTS FROM KEY BANK

We are pleased to announce that if you are the Primary Authorized Representative on a subaccount you will begin to receive a *MONTHLY* account statement directly from Key Private Bank.

PLEASE BE ADVISED THAT IT WILL NOT BE MAILED FROM OUR OFFICE IN SALEM. If you happen to misplace it and need another copy, you can contact our office and we can send you an "unofficial" copy. While we will be reconciling with the bank and keeping our Trust Management Software as up-to-date as possible, the statement that is provided by Key Bank will be considered the official balance.

ANNUAL ACCOUNTREVIEWS

As we progress through this new year, Cici will be resuming the annual account reviews. Because it is so important for us to always have the most current information on our subaccount beneficiaries, we will be sending an Updated Joinder Agreement to be reviewed, updated, signed, and returned to us. At the same time, we will be requesting that you send us any, and all, updates to the government benefits and services that are being received. Having this information on file provides us the ability to effectively administer the subaccounts in the trust and also makes the disbursement request process faster and easier! If ever you have questions or concerns about this process, please contact us so that we can better explain. We are here to help!

TRUST PRESENTATIONS


